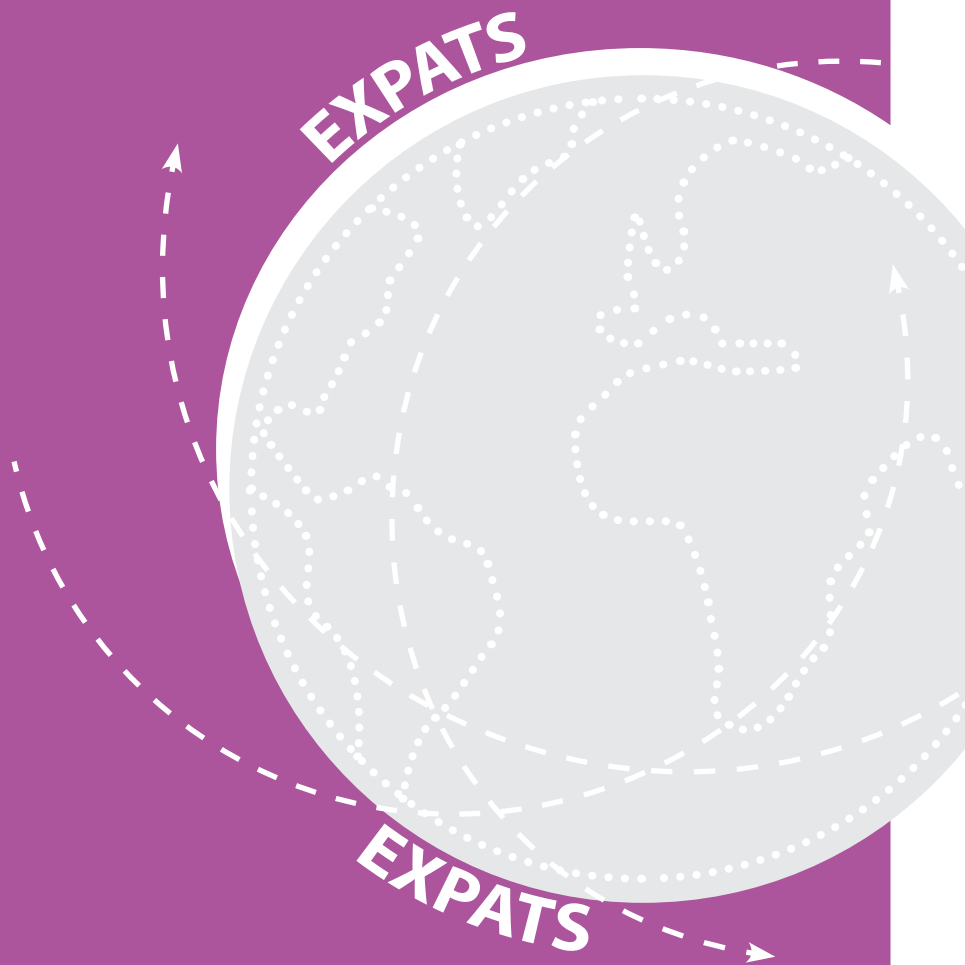

As a new resident of the Netherlands, you will have to pay income tax, just like all other inhabitants. To assess the amount of income tax you have to pay, the Dutch Tax Office requires you to file an annual income tax form. This is not a simple job, there are various benefits and arrangements available to you through the Dutch tax system. The amount you qualify for is based on your individual circumstances. If your family relocates with you, they can also benefit from special arrangements allowed for in Dutch tax law.

PERSONAL SUPPORT Research shows that more than 50% of all expats residing in the Netherlands need personal fiscal assistance. This is understandable given the complexities of the Dutch tax system. For instance; in the year you immigrate or emigrate you receive an M-form for filing your income tax. This form is completely different of the one you would normally receive.

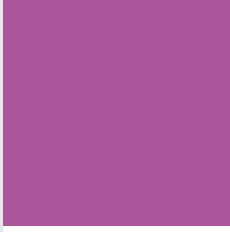

BENEFICIAL ARRANGEMENTS The Dutch government wants to increase the attractiveness of the Netherlands as a destination for knowledge migrants and there are a many beneficial arrangements for workers who fall into this category. The most important benefit is the 30% ruling for knowledge migrants. If you qualify for this category, your employer can pay 30% of your salary free of tax. The ruling also contains an arrangement for tax free support for your children's international school.

Whether or not you qualify for the 30% ruling, there are often other tax related benefits available to you in the Netherlands. These benefits include, care allowance, rent allowance and children's daycare allowance. It is also possible to apply for a deduction related to mortgage interest payments even for your home abroad.
